Governor's Budget

- Anticipated a \$4.7 million reduction in state aid = further cuts
- Governor recommends no further reductions = good thing

Things to Watch

- Potential \$\$ for workforce development
- Community College Capital Construction bill
- State's revenue picture has improved, but still challenges (e.g. K12)
- \$700 Million Rhetoric = tax talks, budget cuts, etc.



FTEIC - Earned 30+ Credits First Year




IPEDS GRADUATION RATES

Building Updates

Ludden Library & Learning Commons

- Planning Started validating and budget alignment
- \$6.2 million budget
- Construction starting late spring/early summer

Crossroads Building

- Planning complete
- Contractor bidding ASAP pending Trustee and WCCC approval
- Construction starting this spring

ACC Classroom Expansion

- Waiting approval by Legislature
- May be on hold as WyoTech discussions ensue

Laramie County Community College

Building Updates

New Residence Hall

- Trying to de-scope to make it viable, but no success thus far
- Exploring various options (e.g., special financing, P3, etc.)

Recreation & Athletics Complex Renovation

- Exploring options for student-funded approach (fees)
- Still would require \$2.5 to \$4 million to be raised privately

Fine Arts Renovations/Expansion

Working for state matching funds (\$7 million)

Why a New Learning Mgt. System?

Challenges and Opportunities

- Increasing funding challenges (budget cuts)
- Political and public pressure for efficiency and coordination
- Bridging the gap with K12 and UW
- Potential for course sharing
- Significant savings through partnership (\$1/4 million for LCCC)
- Phase I Summer/Fall 2016
- Phase II April to July 2017
- Phase III August 2017
- Phase IV Sept 2017 to Present (Implementation)

- University of Wyoming

- June 30th D2L access discontinued








FY19 LCCC Budget







FY19 Budget Development

Revenues

- Local funding may still be improving
- State funding and allocation uncertain hoping for flat
- WCCC removal of tuition cap (Fall 2018)

Investments

- Carving out some \$\$ for Innovation Funds and OTO projects
- Investing in our people, but that will leave less for other things



Class and Comp Plan

Phase I (FY18)

- 70 (18%) Employees Receiving Adjustments
- Total Cost = **\$360,860**

Phase II (FY19 and FY20)

- 196 (52%) Employees Receiving Adjustments
- Total Cost = **\$1.15 Million**
