SUBJECT:

Recommendation for Authorization to Expend Funds for Purchase of Rodeo/Ag Stock

Upon a thorough examination of the costs of continuing to lease tie-down and breakaway calves for the Rodeo program, a team of rodeo coaches and agriculture faculty have proposed purchasing the calves to both provide a significant cost savings and some added experience for agriculture students in the process. What we found in the cost analysis of their plan is that purchasing and selling the calves as opposed to leasing them would be an estimated net savings of approximately \$35,866 annually.

I am therefore recommending that the Board of Trustees authorizes the expenditure up to \$70,000 for the purchase of livestock for the College's rodeo and agriculture programs with the funds coming from currently budgeted areas.

#### Staff Recommendation:

That the Board of Trustees authorize the expenditure of up to \$70,000 for the purpose of purchasing livestock for the rodeo and agriculture programs at LCCC with funds coming from currently budgeted areas.
