Many colleges use this assessment as an annual tool, often in conjunction with a board retreat or meeting. We will be glad to join a board meeting or retreat to guide you through the report. Please let us know if you and your Board need additional support. I am happy to set up a phone or video conference with you and your Board.



I would also like to remind you and your board of our <u>ACCT 2016 Leadership Congress in New Orleans</u> at the Hilton New Orleans Riverside on October 5-8, 2016. Entitled *Leading With Intent*, the annual ACCT Leadership Congress typically hosts about two thousand trustees, college presidents, chancellors, CEOs and leaders in higher education from around the country.
