




Wyoming Community College Commission

SEVERE WEATHER/TORNADO SHELTERS

- Tornado Warning Siren will indicate when to shelter
- RAVE Mobile Safety emergency messaging system will be activated (Tornado, etc.; not for severe thunderstorms)
- Designated shelter areas are indicated by signage and on maps in each building
- Listed on Emergency Procedures Quick Reference Chart

SHELTER IN PLACE

Used in the event of hazardous materials release

RAVE Mobile Safety emergency messaging system will be activated

- Use designated shelter in place rooms
 - 1. Designated with signage and on maps in each building
 - 2. Listed on Emergency Procedures Quick Reference Chart

Shelter in Place kits are maintained in each designated room

ACTS OF VIOLENCE

- Run, Hide, Fight U.S. Dept. of Homeland Security
- Evacuate upon notification of President and/or Law enforcement
 - 1. Evacuate if you determine it safe and appropriate (may be an individual decision)
- Shelter in Place
 - 1. Preplan for best location(s)
 - 2. Does not have to be a designated "Shelter in Place" room
 - 3. Barricade
 - 4. Fight as a last resort
- Lockdown (RAVE Notice)

HEALTH AND SAFETY EQUIPMENT

RAVE Emergency Mass Notification System

- Opt-out system
- Maintained by Public Relations and IT
- Refreshed every 24 hours through Colleague
- Capable of sending emails, text messages, posts to Facebook and Twitter

HEALTH AND SAFETY EQUIPMENT

WYOLINK

A statewide digital trunked public safety communications system designed to coordinate communications between state, local, and federal public safety agencies.

- 1.LCCC is one of the few institutions of higher learning allowed to access this system with a non-sworn Campus Safety department.
- 2. Currently available on Cheyenne campus; approved for ACC upon funding of radio equipment.

- Campus Assessment Response and Evaluation Team
- Mission A multi-disciplinary team responsible for evaluating and responding to reports of individuals who present disruptive or concerning behavior
