This representation letter is provided in connection with your audits of the basic financial statements of Laramie County Community College (the College) as of and for the years ended June 30, 2021 and 2020 for the purpose of expressing an opinion on whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

We confirm, to the best of our knowledge and belief, that as of the date of this letter:

Financial Statements

- 1. We have fulfilled our responsibilities, as set out in the terms of the audit arrangement letter dated August 16, 2021, for the preparation and fair presentation of the financial statements referred to above in accordance with U.S. GAAP.
- 2. We acknowledge our responsibility for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
- 3. We acknowledge our responsibility for the design, implementation and maintenance of internal control to prevent and detect fraud.
- 4. Significant assumptions used by us in making accounting estimates, including those measured at fair value, are reasonable and reflect our judgment based on our knowledge and experience about past and current events, and our assumptions about conditions we expect to exist and courses of action we expect to take.
- 5. Related-party transactions, including those with the Laramie County Community College Foundation and the Laramie County Community College Building Authority, component units for which the College is accountable, and interfund transactions, including interfund accounts and advances receivable and payable, sale and purchase transactions, interfund transfers, long-term loans, leasing arrangements and guarantees, have been recorded in accordance with the economic substance of the transaction and appropriately accounted for and disclosed in accordance with the requirements of U.S. GAAP.
- 6. All events subsequent to the date of the financial statements, and for which U.S. GAAP requires adjustment or disclosure, have been adjusted or disclosed.
- 7. The effects of all known, actual or possible litigation and claims have been accounted for and disclosed in accordance with U.S. GAAP.

- 8. We acknowledge our responsibility for the selection and application of accounting policies. In that regard, all accounting policies used by us during the year are deemed appropriate.
- 9. We have reviewed long-lived assets to be held and used for impairment whenever events or changes in circumstances have indicated that the carrying amount of the assets might not be recoverable and do not believe any adjustments are necessary.
- 10. We believe that the actuarial assumptions and methods in the Wyoming Retirement System's report used to measure pension liabilities and costs for financial accounting purposes are appropriate in the circumstances.
- 11. We believe that the actuarial assumptions and methods in the State of Wyoming Employee Group Insurance Retiree Health Plan actuarial valuation report used to measure postemployment benefits other than pensions (OPEB) liabilities and costs for financial accounting purposes are appropriate in the circumstances.
- 12. Arrangements with financial institutions involving compensating balances or other arrangements involving restrictions on cash balances, lines of credit, or similar arrangements have been properly disclosed.
- 13. The Laramie County Community College Building Authority has authorized approximately \$6.8 million in lease revenue bonds. The bonds have yet to be issued.
- 14. The Laramie County Community College Building Authority is compliant with all bond reserve fund requirements.
- 15. Net position classifications have been properly recorded and disclosed within the basic financial statements.
- 16. We have no direct or indirect legal or moral obligation for any debt of any organization, public or private, that is not disclosed in the financial statements.
- 17. We have complied with all aspects of laws, regulations, and provisions of contracts and agreements that would have a material effect on the financial statements in the event of noncompliance.
- 18. We have informed you of all uncorrected misstatements. The uncorrected misstatements are included in the *Summary of Uncorrected Misstatements* attached as Appendix A.

Information Provided

- 19. We have provided you with:
 - a. Access to all information of which we are aware that is relevant to the preparation and fair presentation of the financial statements such as records, documentation, and other matters;
 - b. Additional information that you have requested from us for the purpose of the audits;
 - c. Unrestricted access to persons within the College from whom you determined it necessary to obtain audit evidence; and
 - d. Minutes of the meetings of the governing board and committees, or summaries of actions of recent meetings for which minutes have not yet been prepared.
- 20. All transactions have been recorded in the accounting records and are reflected in the financial statements.

- 21. It is our responsibility to establish and maintain internal control over financial reporting. One of the components of internal control is risk assessment. We hereby represent that our risk assessment process includes the identification and assessment of risks of material misstatement due to fraud. We have shared with you our fraud risk assessment, including a description of the risks, our assessment of the magnitude and likelihood of misstatements arising from those risks, and the controls that we have designed and implemented in response to those risks.
- 22. We have no knowledge of allegations of fraud or suspected fraud affecting the College's financial statements involving:
 - a. Management.
 - b. Employees who have significant roles in internal control.
 - c. Others where the fraud could have a material effect on the financial statements.
- 23. We have no knowledge of any allegations of fraud or suspected fraud affecting the College's financial statements received in communications from employees, former employees, analysts, regulators, short sellers or others.
- 24. We have no knowledge of noncompliance or suspected noncompliance with laws and regulations.
- 25. We are not aware of any pending or threatened litigation and claims whose effects should be considered when preparing the financial statements.
- 26. We have disclosed to you the identity of all of the College's related parties and all the related-party relationships and transactions of which we are aware.
- 27. We are aware of no significant deficiencies, including material weaknesses, in the design or operation of internal controls that could adversely affect the College's ability to record, process, summarize, and report financial data.
- 28. We are aware of no communications from regulatory agencies concerning noncompliance with, or deficiencies in, financial reporting practices.
- 29. We believe that the information obtained from the audited financial statements of, and other participant information provided by, the Wyoming Retirement System is appropriate in the circumstances. We did not give instructions, or cause any instructions to be given, to the plan or its auditor in an attempt to bias their work, and we are not otherwise aware of any matters that have had an impact on the independence or objectivity of the plan or its auditor.
- 30. We believe that the information obtained from the State of Wyoming Employee Group Insurance Retiree Health Plan actuarial valuation report is appropriate in the circumstances. We did not give instructions, or cause any instructions to be given, to the plan or its actuary in an attempt to bias their work, and we are not otherwise aware of any matters that have had an impact on the independence or objectivity of the plan or its actuary.
- 31. During the course of your audits, you may have accumulated records containing data that should be reflected in our books and records. All such data have been so reflected. Accordingly, copies of such records in your possession are no longer needed by us.

- 33. With respect to Management's Discussion and Analysis, the Schedule of the College's Proportionate Share of the Net Pension Liability, the Schedule of the College's Contributions, the Schedule of the College's Proportionate Share of the Total OPEB Liability, and Notes to Required Supplementary Information presented as required by the Governmental Accounting Standards Board to supplement the basic financial statements:
 - a. We acknowledge our responsibility for the presentation of such required supplementary information.
 - b. We believe such required supplementary information is measured and presented in accordance with guidelines prescribed by U.S. GAAP.
 - c. The methods of measurement or presentation have not changed from those used in the prior period.
 - d. There are no significant assumptions or interpretations regarding the measurement or presentation of such information.
- 34. We are in agreement with the adjusting journal entries that you have identified through your audit procedures. The adjustments to the original trial balance presented for audit are included in the *Summary of Recorded Adjustments* attached as Appendix B.
