




Community Colleges Nationally: Enrollments






Colleges in Wyoming: Enrollments













Enrollment Change: Year-on-Year



LCCC fall 2023 Enrollments: Point-in-time delta across the last 4-years







These are the number of students LCCC would have annually if all students took 24 credit hour loads during the academic year.



LCCC and USA Retention Trends




Retention =

Fall to Spring Persistence & Momentum at LCCC




Persistence = the percentage of students that either returned to LCCC in the spring from the preceding fall or graduated from LCCC.

Why? An indicator of term on term success and momentum as an institution.






LCCC Course Success* by IPEDS Race / Ethnicity Categories





LCCC Graduation Rate Over Time




Graduation Rate = first-time, full-time, degree seeking students that graduate within 150% of normal time.





LCCC Number of Credentials per 100 Student FTE




This represents the total number of credentials produced per year for every 100 Student FTE

100 Student FTE = 100 full-time equivalencies (i.e., 12 credit hour load)



LCCC Credentials and Graduates Across Time by Gender




LCCC Graduation & Transfer Rate Over Time









Response rates for the survey vary greatly from 7% to 28% and should be interpreted as such.








High School Student Enrollment Detail






Military Status Enrollment and Credits






First-Generation Status Enrollment and Credits






Age Group Enrollments at LCCC






Gender Group Enrollments at LCCC






Aspen Underrepresented Minority Group Enrollments at LCCC
