#### Rationale for Inclusion

Student scholarships managed by the College Foundation are a stable and sustaining source of support for our students. These private donations are awarded based on criteria established by donors and administered by the College along with external agency funds. These measures demonstrate to those donors and external agencies that these funds are distributed according to their specifications.

#### Statistic of Interest

Two statistics are used: (H.3.a) the number of students receiving scholarships through the LCCC Foundation during the academic year and (H.3.b) the total amount distributed to these students.

#### Methodology

From Colleague records, download student IDs and amounts for all LCCC Foundation scholarships dispersed during the prior academic year. From this list, (1) count the number of unique individuals and (2) calculate the total amount distributed.








Figure 8. Percent of all undergraduates receiving aid by type of aid: 2011-12




Figure 6. Percent of full-time, first-time degree/certificate-seeking undergraduate students who received grant or scholarship aid from the federal government, state/local government, or the institution, or loans, by type of aid: 2011-12


Figure 7. Average amounts of grant or scholarship aid from the federal government, state/local government, or the institution, or loans received, by full-time, first-time degree/certificate-seeking undergraduate students, by type of aid: 2011-12

# **Hathaway Scholarship**

#### **Four Levels**

- 1. Honors (\$1,680/semester)
  - Specified Curriculum + 3.5 GPA and 25 ACT
- 2. Performance (\$1,260/semester)
  - Specified Curriculum + 3.0 GPA and 21 ACT
- 3. Opportunity (\$840/semester)
  - Specified Curriculum + 2.5 GPA and 19 ACT
- 4. Provisional Opportunity (\$840/semester)
  - Specified Curriculum + 2.5 GPA and 17 ACT or 12 WorkKeys
  - Good for four semesters at a CC, and pending completion, student qualifies for another four at UW or a CC.

## **Institutional Aid**

### **Need-Based Aid**

 Need-Based Aid programs at LCCC are awarded to individuals who have unique challenges (e.g., financial, environmental, etc.) inhibiting their ability to participate and persist in higher education but can benefit equally from a college education should their unique challenges be mitigated, and/or to individuals who are provided special opportunities for engaging in higher education at a mitigated cost (e.g., senior citizens, high school students, etc.). Need-Based Aid programs are included within three sub-categories: (1) financial hardship/opportunity; (2) special populations; and (3) federal program match.

## **Questions Trustees Should Know**

- Programs, practices, and resources to encourage and assist students in claiming federal tax credits or deductions for which they are eligible.
  - Currently revamping the financial aid pages on the LCCC Website. The pages will be updated to include all aid available, how to apply for it, strong encouragement for FAFSA filing, and information about tax deductions and credits available to students.
  - It should be noted that when a student files his/her FAFSA, the Student Aid Report (SAR) includes the tax benefit information as well as the FAFSA confirmation page. In 2012-2013, we had 2,782 students with FAFSAs for all of the year. For 2014-2015 we have 3,644 students with FAFSAs as of this morning.
  - Students are also provided this information when they complete their financial aid exit counselling.
