 - Changes in Fee Changes. Some courses have different fees; Changes go in August 2026. Some will increase; some will decrease. Online and in person Fees will level out. Net: \$4081.15 out of 62 classes. Fees will be added to tuition fees.

Approved concealed carry-on campus if you have Wyoming license with very specific rules, can't be noticeable, can't be in classrooms or in cars unless in a very specific container with a very specific key El: Biometric Safe. Some rooms can't be in at all, El: in rooms with kids, and in rooms with chemicals. No one is allowed to ask a student if they have a weapon with this policy. In dorms, rooming will try to be based on 21+ or not, and if roommates have concealed carry, other roommate would be notified ahead of time and if they aren't ok with it, they will get a new roommate.
